And whereas, Mr. Avinash Kumar, a candidate of OBC category does not possess also a valid OBC certificate as on Cutoff Date i.e. 04.07.2021 as the candidate possess two OBC certificates i.e. certificate No. 90500000233882 dated 03.03.2017 issued by the SDM (Alipur), Delhi on the basis of OBC certificate issued **to his sister** – Deepa Kumari who belongs to **'KAHAR' community of 'West Bengal State'** vide Certificate No. WB1102OBC201202557 dt. 07.08.2012 **instead of Delhi State** and another OBC certificate No.90500000534137 dated 10.05.2019 issued by Tehsildar (Alipur), Delhi on the basis of previous OBC certificate dated 03.03.2017 issued to self (Avinash Kumar) belongs to KAHAR community of DELHI State for the purpose "For applying for appointment to Posts under the GOI" and both the aforementioned OBC certificates are not valid for the post of TGT (Natural Science_ - Male according to Point Numbers 6(ii), 6(iii) & 6(iv) of Vacancy Notice Advertisement No. 02/21 dated 12.05.2021, RRs and prescribed Guidelines/ Instructions/ Orders issued by GOI/ Govt. of NCT of Delhi, time to time towards availing "Reservation Benefits".
