ORDER

**Cancellation of offer of Appointment and candidature to the post of TGT(ENGLISH) FEMALE, Post Code 51/21**

Whereas, Ms. Shilpi Kumari, DoB 02.02.1989, Roll No. 121205101348, Category OBC, has been nominated by the DSSSB to the post of TGT (ENGLISH)-FEMALE against Post Code 51/21 vide Result Notice No. 1408 dated 20/07/2022 in the Directorate of Education, Govt. of NCT of Delhi and their e-dossiers received from DSSSB for further proceedings of appointment. During the Document verification, a Deficiency Memo dated 03.11.2023 had been issued to the candidate in respect of following deficiency:

**1. OBC and NCL Certificate not issued before cut off date.**

The candidate has submitted an Affidavit duly signed by the Executive Magistrate/Tehsildar, Rajouri Garden, wherein she has declared that she has applied for her certificate on 15.06.2021 which is before cutoff date of the application for the post of TGT (English) Female i.e. 10.07.2021 but due to COVID lock down situation her OBC Certificate was issued by the Revenue Authorities on 26.07.2021 which is after the closing date of the application and a NCL Certificate for the period 2021-22 was issued by the Tehsildar on 07.11.2021.

On the directions of worthy Director of Education, the matter was forwarded to the Services Department, GNCT of Delhi for their necessary directions/opinion. The matter was examined by the Services Department, GNCT of Delhi. As per instructions of the Services Department "... the appointing authority, before appointing a person seeking appointment on the basis of reservation to OBCs should verify the veracity of the community certificate submitted by the candidate and also the fact that he/she does not fall in creamy layer on the crucial date. The crucial date for this purpose may be treated as the closing date for receipt of applications for the post except in cases where crucial date is fixed otherwise". An Office Memorandum No. F.20(2)/Services/Vacancy Cell/2023/199-216 dated 05.02.2024 regarding "Instruction on procedural aspects etc in the matter of non-creamy layer as well as EWS certificates and other related matters" is also issued by the Services Department.

Since in the matter of Ms. Shilpi Kumari, DoB 02.02.1989, Roll No. 121205101348, the OBC Certificate issued by the Revenue Department is **after the cut off date i.e. on 26.07.2021** whereas the **cut off date** for TGT (English) Female, Post Code 51/21 was **10.07.2021**, Ms Shilpi Kumari is not eligible to the post of TGT (English) Female, Post Code 51/21 in OBC Category.

Hence, the Director of Education being the Competent Authority ordered to **cancel** the candidature of Ms. Shilpi Kumari, DoB 02.02.1989, Roll No. 121205101348, Category OBC under Post Code 51/21 and return her dossier to the DSSSB.

This issues with the prior approval of the Competent Authority.
