ORDER

<u>REJECTION/ CANCELLATION OF CANDIDATURE IN R/O SIDHARTH KUMAR FOR THE</u> <u>POST OF TGT(HINDI) MALE UNDER POST CODE-34/21</u>

Whereas, Sh. Sidharth Kumar, D.O.B. 23.03.1998, Roll No. 121103400117 was provisionally nominated & selected by the DSSSB for further processing for appointment to the post of TGT HINDI (Male) post code 34/21 under EWS category in Directorate of Education, Govt. of NCT of Delhi and he was called for document verification vide this Office memorandum no.: F.NO. DE.3(28)/DRC/E-III/TGT/HINDI/MALE/2022/5159 dated 13.10.2022 followed by subsequent reminders and final reminder dated 10.02.2023 issued to Sh. Sidharth Kumar with the directions to submit his acceptance.

Whereas, in response to this, the said candidate reported at scheduled date & time of DV and accepted the offer of appointment.

And whereas, during document verification, it was found that candidate has applied and selected in EWS category and EWS certificate bearing no. EWSCO/2022/34086 has been issued after cut-off date i.e. 11.02.2022 valid for the year 2021-22.

And whereas deficiency memo was issued vide letter No. DE.3(28) / DRC / E-III / TGT / Hindi/Male/2022/ 212 on 15.02.2023 and the reply submitted by the candidate is not up to the merit.

And whereas as per advertisement no. 02/21 by the DSSSB it was specifically mentioned that candidates who wish to be considered against reserved vacancies and/ or to seek age relaxation must be in possession of relevant certificates (EWS/SC/ST/OBC/Non Creamy layer/PWD/ Education Experience etc.)issued by the competent /notified authority (in prescribed format) or before the cut off date(closing date of advertisement) otherwise their claim for any category will not be entertained and their application will be considered against Un-reserved vacancies, if eligible otherwise.

And whereas, this issue has been considered in this Directorate and after deepen examination of the matter, the same was referred to worthy Chief Secretary, Delhi for further instructions in the matter. Worthy Chief Secretary, constituted a committee consisting of senior officers of Govt. of Delhi to examine the matters in consonance with the OM/instructions/guidelines issued by the Govt. of India from time to time.

Whereas the Committee so constituted examined the issue raised in the instant matter which covered under the terms of reference assigned by the Chief Secretary, Delhi to the said Committee and vide its report the committee addressed the said issue, which has also been approved by the competent authority and the Services Department (Services-IV Branch) vide UO Note No.F.19(07)/2020/S-IV/226 dated 05.02.2024 has stated as under: -

"....... the Committee unanimously agreed to abide by the instructions/OMs issued by DoPT, Govt. of India and recommended that the EWS/NCL Certificates issued/ submitted beyond crucial/cutoff date may not be entertained. Further, regarding the cases where the certificates were issued before completion of the period for which income is to be computed, were also not found to be as per the DoPT norms, hence such cases may also not be entertained."

Whereas on service matters, including reservation in civil posts, the OMs/instructions etc. issued by Govt. of India from time to time are applicable in the Govt. of N.C.T. of Delhi. Accordingly, the following stipulation of DoPT's OM No. 43011/11/2022-Estt. Res.II dated. 19.09.2022.

"The OMs/ Instructions etc. issued in respect of EWS candidates by DoPT, Govt. of India provides that crucial date for submitting income and asset certificate by the candidate may be treated as the closing date for receipt of application for the post, except in cases where crucial date is fixed otherwise. The crucial date for submission of Income & Asset Certificate (Cut-off date) shall be clearly mentioned in the advertisement published by the recruiting agencies. Income & Asset Certificates issued subsequent to the crucial date and for the later Financial Year shall be treated as major discrepancies."

And whereas Sh. Sidharth Kumar was not in possession of valid EWS certificate issued on or before cut-off date i.e. 04.07.2021.

Therefore, the candidature of Sh. Sidharth Kumar, D.O.B. 23.03.1998, Roll No. 121103400117 for the post of TGT (Hindi) Male, post code 34/21 nominated by DSSSB under EWS category vide no. 4(612)/DSSSB/CC-I/2021/1049-1055 dated 02.08.2022 result notice no. 1477 is hereby Rejected/ Cancelled in the light of the instructions / guidelines issued by the Govt. of India vide DOPT OM No.36039/1/2019-Estt (Res) dated 31.01.2019 which was endorsed by the services Department, GNCT of Delhi vide no F.19(10)/2018/S-IV/1595 dated 28.05.2019 which was further clarified by the FAQ issued by GOI, vide DoPT OM no. 43011/11/2022-Estt.(Res-II) dated 19.09.2022 vide question no. 21 & 23 which was further reiterated by the committee consisting of higher officer of GNCT of Delhi issued by U.O. No.F.19(07)/2020/S-IV/226 dated 05.02.2024.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."
