Cancellation of Candidature for the post of TGT Computer Science-91/20

Ms. Neha Rani, Roll No. 121109102151 (Cat. UR) has been nominated by the DSSSB for the post of **TGT Computer Science** under post code-91/20 and accordingly offer of appointment was issued to her.

Whereas, after successfully completion of verification of documents, **Mr./Ms. Neha Rani (Emp Id:20232918)** was issued appointment vide Order No. F.DE.4(33)/DRC(E-IV)/TGT(CS)/2022/8827-38, posting ID 20230535 to the post of TGT Computer Science with the direction to join his/her duties on his/her place of posting latest by 31/07/2023 failing which his/her appointment shall stand cancelled without any further communication.


Further, **Ms. Neha Rani** was also granted final opportunity vide letter dated **27/09/2023** with the prior approval of the competent authority to join the duty by 10/10/2023.

And, whereas the official concerned neither joined their duties nor submitted any request/representation for extension to join the post, which shows that she is unwilling to join the post of TGT Computer Science.

Therefore, in view of the above facts and circumstances and, since the candidate has willfully chosen neither to join the school allotted to him/her nor requesting for any extension for period of joining the post, the provisional appointment order issued to **Ms. Neha Rani** vide **Posting ID 20230535** is hereby withdrawn and candidature stands cancelled.
