CANCELLATION ORDER

Whereas, the Candidate namely **Mr. UMESH BHAKAR** (21.08.1992), Roll No. 113103500258, a candidate of 'UR' category was provisionally nominated for the post of TGT (Natural Science) - Male under post code-35/21 (as per Vacancy Notice Advertisement No. 02/21) by the Selection Mechanism Authority of DSSSB vide their Result Notice No.145 dated 28.07.2022 and his dossier received from DSSSB for further proceedings towards consideration of Appointment for the aforesaid post.

And whereas, after the preliminary scrutiny of documents available in e- dossier, a Memorandum towards 'Offer of Appointment' was issued on 27.07.2023 to the aforesaid candidate with the directions to appear in person on the scheduled Date, Time and Venue alongwith all the requisite documents for Documents Verification.

And whereas, it was observed during the course of documents verification conducted by the assigned Team that the aforesaid candidate does not possess following requisite documents: -

1. Found father's name mismatch in First Semester's Marksheet of B.Sc.

And whereas, in this regard, an opportunity was given to the Mr. **UMESH BHAKAR** by issuing Deficiency Memo No F. No.DE.3 (29)/DRC/E-III/TGT (NATURAL SCIENCE)/MALE/2022/2427 dated 09.08.2023 and followed by subsequent reminders on 25.08.2023 & 13.12.2023. The candidate did not reply in reference to first two deficiency memos, however he replied in reference of second reminder dated 13.12.2023 through his registered email on 08.01.2024 vide which he informed that **"I am not interested in joining this Post. You can withdraw my name from this post. I assure you that I will not claim this post in future. You can do the needful."**

Keeping in view of the above facts & circumstances, it is clear that aforesaid candidate is not willing to be appointed for the post of TGT (Natural Science) - Male, , therefore, the candidature/nomination of Mr. **UMESH BHAKAR** (Roll No 113103500258), a candidate of 'UR' category, for the post of TGT (Natural Science) - Male, post code 35/21 is hereby **withdrawn/rejected** accordingly with the retrospective date of 'Offer of Appointment'.

"No claim for Appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the Department, in future. "
