ORDER

Sub: Cancellation/Rejection of Candidature for the post of TGT(Maths) Female, Post Code-37/21.

Whereas, the under mentioned 19 (Nineteen) candidates under EWS category were nominated for the post of TGT (Maths) Female, Post code 37/21 as per vacancy advertisement no. 02/21 by the Selection Mechanism Authority i.e. DSSSB vide Result No.1475 dated 29/07/2022 and their respective e-dossiers received from DSSSB for further proceedings of appointment.

And whereas, as per U.O. no. F.DE.3 (7)/DRC/E-III/TGT/Misc./2023/154 dated 13.02.2024 vide which mentioned that a proposal was moved to decide on the issue of validity/applicability of the EWS Certificate issued after cut-off date with validity for the year 2021-22 and also the EWS Certificate issued before cut off date (but between the period 01.01.2022 to 31.03.2021) with validity for the year 2021-22 in the context of various post of TGTs (Male/Female). The chief Secretary, Delhi constituted a Committee of Senior Officers of Government of Delhi to examine the matter and as per Services Department vide U.O. No. F.19 (07)/2020/S-IV/226 dated 05.02.2024 in the matter of NCL as well as EWS Certificates involving following two points:-

- a) *Format of the Non-Creamy Layer (NCL) as well as EWS certificates.*
- b) *Crucial date of w.r.t. to Non-Creamy Layer as well as EWS certificate.*

Accordingly, on the basis of the report of the committee, the existing instructions/guidelines issued by Govt. of India in respect of two of the following points:

- i) The present formats of the certificates issued by Revenue Department, GNCTD are as per the prescribed format of DoPT, Govt. of India. Therefore, no changes in present formats are called for.
- ii) The OMs/ Instructions etc. issued in respect of EWS candidates by DoPT, Govt. of India provides that crucial date for submitting income and asset certificate by the candidate may be treated as the closing date for receipt of application for the post, except in cases where crucial date is fixed otherwise. The crucial date for submission of Income & Asset Certificate (Cut-off date) shall be clearly mentioned in the advertisement published by the recruiting agencies. Income & Asset Certificates issued subsequent to the crucial date and for the later Financial Year shall be treated as major discrepancies.

And whereas in view of the above, e-dossier of the candidates were scrutinized as per the provisions of the Recruitment Rules for the post of TGT (Maths) female and it was found that following 19 (nineteen) EWS candidates either not in possession of EWS certificate valid for the year 2021-22 or have this certificate issued after cut off date/before cut off date which is not in conformity with the provisions of DOPT OM dated 31.01.2019 which was endorsed by the Services Department GNCT of Delhi vide their letter dated 28.05.2019. And also despite of giving various memos to candidates, no one candidate was able to submit the valid EWS certificate.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."

This issues with the prior approval of Competent Authority vides No.1302/DE dated 21/02/2024.




