

Consequent upon nomination through Delhi Subordinate Services Selection Board to the post of the TGT-Social Science (Male) vide no. F.1(70)/DSSSB/P&P/09/1375 dated 18.01.2024 and in compliance of Hon'ble Tribunal order dated 24.05.2023 in the M.A No. 1202/2023 in O.A No. 1912/2018 and with the prior approval of the Competent Authority, the following candidate(s) are hereby appointed purely on Temporary and provisional basis, for the Post of TGT-Social Science (Male) Vide advertisement no. 01/2010 & post code 09/10 in the pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4600 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him/her. The Candidate has been medically examined by the Govt. Hospital and declared FIT and his individual report placed in his respective dossier. In case of OBC candidate the appointment will be provisional and at the time of joining, the candidate will have to submit and undertaking to concerned Head of the school/office that "It is hereby undertaken that the information furnished by me are true and correct and my OBC certificate is as per provisions contained in DSSSB Advertisement No. 01/2010. In the event of OBC certificate being found false or detected incorrect or incomplete at any stage or any ineligibility being detected after the appointment, my candidature/appointment is liable to be cancelled/terminated automatically without any notice and action may be taken against me by the Department as per rules". Subsequently, the OBC/NCL verification report will be checked by the DDE concerned. If the OBC certificate of the candidate concerned is found invalid, his candidature will be terminated with immediate effect. The candidate is hereby directed to report to his respective place of posting latest by 10.05.2024 failing which his appointment shall stand cancelled without any further communications. (iii) Verification of recognition of institute/university and NCTE, from which the candidate has acquired his degree and on which they rely upon for the said post. 
