ORDER

Cancellation of Candidature for the post of TGT Computer Science-91/20

Whereas, **Ms. KAMIA**, D.O.B - 01.06.1987, Roll No.111809100371, Selection Category-OBC was nominated by the DSSSB for the post of TGT Computer Science, under post code-91/20 in Directorate of Education, Govt. of NCT of Delhi vide result notice no. 134 dated 28.04.2022 and the candidate was issued an Offer of Appointment dated 24.06.2022 with direction to appear on 15.07.2022 for Document Verification. During Document Verification, a Deficiency Memo was issued vide even letter no dt. 29.09.2022.

Whereas, the Candidate has submitted letter vide dy. No. 2378 dated 26.12.2023 and sent an email dated 29.02.2024 on the official email address of the E-IV DR Cell for stopping the Appointment process and also intimated that in future she will not claim for this post.

In view of the above, it is presumed that the candidate is not interested in the appointment to the post of TGT Computer Science, under post code-91/20 in Level 7 Pay Matrix (Pre-revised Pay Band - 9300-34800 with Grade Pay of Rs. 4600/-) plus usual allowances as admissible under the Rules.
