CANCELLATION ORDER

Whereas, the Candidate namely **Mr. KRISHAN KUMAR (DOB. 09-06-1992)**, Roll No. **112903500277**, a candidate of 'UR' category was provisionally nominated for the post of TGT (Natural Science) - Male under post code-35/21 (as per Vacancy Notice Advertisement No. 02/21) by the Selection Mechanism Authority of DSSSB vide their Result Notice No.145/2021 dated 28.07.2022 and his dossier received from DSSSB for further proceedings towards consideration of Appointment for the aforesaid post. Accordingly, a Memorandum i.e. 'Offer of Appointment towards Documents Verification' was issued to him on 27.06.2023 after preliminary scrutiny of dossier of the candidate.

And whereas, after successfully completion the verification of documents, **Mr. KRISHAN KUMAR** (Emp. Id: **20233605**) was given Provisional Appointment vide Order No. No. F. DE 3(29)/DRC/E-III/TGT (Natural Science)/MALE/2022/170 dated **27/09/2023** (Posting ID **20230612**) to the post of TGT (Natural Science) - Male with the direction to join his duties at assigned place of posting latest by **27/10/2023** failing which his Appointment shall stand cancelled without any further communication. Further, **Mr. KRISHAN KUMAR** was granted extension of time for joining the duties firstly **upto 26.11.2023** vide Order dated 08.11.2023 (Extn. Id:20094254) on considering his request dated 26.10.2023. Further, another extension was granted upto 26.12.2023 vide Order dated 30.11.2023 (Extn. Id:20094266) on considering his request dated 24.11.2023 however, he did not join his duties. Thereafter, a 'Final Opportunity Memo' number F.No. DE.3 (29)/(3)/DRC/E-III/TGT(N. Sc.)/Male/2022/ 1909-10 was issued to the aforesaid candidate on 12.02.2024 with the directions to join his duties at assigned place of posting latest by 22.02.2024 and submit a copy of his Joining Order in DRC (E-III Branch) failing which his candidature for the aforesaid post will be cancelled without any further notice, however, he again failed to join his duties.

And, whereas, the aforesaid candidate neither joined his duties in DOE nor submitted any request/representation through any mode, till date for granting extension of time to join the duties for the aforesaid post, which shows that he is unwilling to join the duties for the appointed post of TGT (Natural Science) - Male.

Therefore, in view of the above facts and circumstances, and since the Candidate has willfully chosen neither to join the duties at concerned allotted school to him nor requesting for any extension for a particular period for joining the assigned duties to the appointed post, the 'Provisional Appointment Order dated **27/09/2023** (name at sl. no.01) issued in favour of **Mr. KRISHAN KUMAR** (Emp. Id: **20233605**), is hereby **withdrawn** and his candidature for the post of TGT (Natural Science) – Male, **stands cancelled** accordingly with the retrospective date of 'Memorandum: Offer of Appointment'.

CANCELLATION ORDER

Whereas, the Candidate namely **Mr. AKASH MEENA (DOB. 20-10-1997)**, Roll No. 111903500311, a candidate of 'ST' category was provisionally nominated for the post of TGT (Natural Science) - Male under post code-35/21 (as per Vacancy Notice Advertisement No. 02/21) by the Selection Mechanism Authority of DSSSB vide their Result Notice No.145/2021 dated 28.07.2022 and his dossier received from DSSSB for further proceedings towards consideration of Appointment for the aforesaid post. Accordingly, a Memorandum i.e. 'Offer of Appointment towards Documents Verification' was issued to him on 26.06.2023 after preliminary scrutiny of dossier of the candidate.

And whereas, after successfully completion the verification of documents, Mr. AKASH MEENA (Emp. Id: **20233280**) was given Provisional Appointment vide Order No. No. F. DE 3(29)/DRC/E-III/TGT (Natural Science)/MALE/2022/148 dated **16/08/2023** (Posting ID 20230575) to the post of TGT (Natural Science) - Male with the direction to join his duties at assigned place of posting latest by **16/09/2023** failing which his Appointment shall stand cancelled without any further communication. Further, Mr. **AKASH MEENA** was granted extension of time for joining the duties firstly **upto 01.10.2023** vide Order dated 21.09.2023 (Extn. Id: 220094186) on considering his request dated 13.09.2023. Further, after receiving multiple applications from the candidate, extension time of joining the duties were granted several times by the Department and lastly **upto 15.11.2023** vide Extension Order dated 31.10.2023 (Extension ID: 20094243), however, he did not join his duties within stipulated period. Thereafter, a 'Final Opportunity Memo' number F.No. DE.3 (29)/(3)/DRC/E-III/TGT(N. Sc.)/Male/2022/1913-14 was issued to the aforesaid candidate on 12.02.2024 with the directions to join his duties at assigned place of posting **latest by 22.02.2024** and submit a copy of his Joining Order in DRC (E-III Branch) failing which his candidature for the aforesaid post will be cancelled without any further notice, **however, he again failed to join his duties.**

And whereas, the aforesaid candidate intimated also vide an attachment through his regd. email id that he will not join to the post of TGT (Natural Science) - Male as he has been selected to the post of teacher in his home state.

Therefore, in view of the above facts and circumstances, the Candidate is unwilling to join the duties in Directorate of Education at allotted school to him and thus the 'Provisional Appointment Order dated **16/08/2023** (name placed at sl. no.04) issued in favour of **Mr. AKASH MEENA** (Emp. Id: 20233280), is hereby **withdrawn** and his candidature for the post of TGT (Natural Science) – Male, **stands cancelled** accordingly with the retrospective date of 'Offer of Appointment'.
