ORDER

**CANCELLATION/REJECTION OF CANDIDATURE FOR THE POST OF TGT SANSKRIT
(FEMALE) POST CODE-145/17**

Whereas, the result of Ms. Kanta, bearing roll. No. 2520007913 for the post of TGT Sanskrit Female, Post code 145/17, was kept on hold for verification of OBC (Delhi) status by DSSSB vide at Sl. No. 38 of result notice no. 394 dated 28.03.2019 as the candidate has acquired qualification from other than Delhi however, she has caste certificate of OBC category issued from GNCT of Delhi.

And whereas, the result of Ms. Kanta was declared & provisionally selected to the post of TGT Sanskrit Female (Post Code 145/17) subject to verification of their OBC (Delhi) status at the level of user department i.e. Directorate of Education by DSSSB vide Supplementary result notice no. 534 dated 14.10.2019 with the specific remarks mentioned against her Roll. No.2520007913 at Sl. No. 38 of said result notice & the same is reproduced herein below:

And whereas, an offer of appointment was issued to her on 08.06.2021 and was called for document verification on 21.06.2021 and during the document verification a deficiency memo was issued to her for submitting of requisite documents/clarification.

And whereas, in response of memorandum dated 21.06.2021, the reply received from Ms. Kanta was examined and found incomplete and without supportive document, and the same was informed to candidate on dated 04.02.2022 vide which it was directed that:

'Therefore, you are hereby again directed to submit the reply of point 2 of deficiency memo dated 21.06.2021, whether your OBC certificate dated 28.09.2000 issued on the basis of husband/on virtue of marriage and along with produce certificates/documents valid for issuance of OBC (Delhi) certificate as per the SOP of Revenue Department, pertaining to residence in Delhi before 1993, which was submitted at the time of issuance of OBC certificate within 07 days, failing which the action deemed fit may be taken in this regard without any further communication'.

And whereas, on non receipt of reply of memorandum dated 04.02.2022, the final reminder dated 31.03.2022 was also issued to candidate but candidate has not responded till now, which reveals that candidate has not possessed the required document upon which her OBC (Delhi) certificate was issued & nothing to say about OBC certificate issued on husband basis while caste is determined by paternal side not marriage/spouse basis.

And whereas, the matter of appointment of candidate kept on hold due to unsatisfactory reply received from candidate and Revenue Department, in spite of reminders have been issued time to time.

As per the direction of Hon'ble CAT the matter of appointment of Ms. Kanta is to be decided by user department in compliance of Hon'ble CAT order dated 30.05.2023.

And whereas, the matter in detail alongwith relevant documents have been placed before Competent Authority and it has been approved for rejecting/cancelling the candidature of Ms. Kanta, bearing roll. No. 2520007913 for the post of TGT Sanskrit Female, post code 145/17.

Therefore, keeping in view of the above facts & circumstances, the offer of appointment dated 08.06.2021 issued to **Ms. Kanta, bearing roll. No. 2520007913, DOB-11.07.1974 under OBC category** is hereby withdrawn from retrospective date and her candidature is hereby stand cancelled/rejected for the post of TGT Sanskrit Female, post code 145/17 and dossier is being returned to DSSSB for further necessary action at their end.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."

This issues with the prior approval of the Competent Authority.
