**Cancellation of Offer of Appointment to the post of PGT (MATHS) MALE, POST Code 28/20**

Whereas, **Sh. AVINASH VERMA**, D.O.B. **24/09/1982**, Roll No. **112302800135** has been nominated by the DSSSB for the post of PGT (Maths) Male against Post Code 28/20 vide letter no. F.4(278)/P&P/DSSSB/2019/692 dated 24.05.2022 vide Result Notice No. 855 dated 10.05.2022. During preliminary scrutiny of document received from DSSSB it was found that the OBC Certificate No. 90500000639874 dated 29/06/2020 has been issued to the candidate which is after cut off date i.e. 22/02/2020 of DSSSB advt. no. 02/20 and the said candidate was advised to submit the requisite documents vide this Directorate Deficiency Memorandum No. 2496 dated 27/10/2022. In reply to the deficiency memorandum he submitted that he got his OBC certificate number on dated 21/02/2020. In this regard an affidavit vide no 344 dated 09/11/2022 also submitted by the candidate stating that he got his OBC certificate number on 21/02/2020, But due to Covid-19 his certificate was issued on 29/06/2020.

And Whereas, an offer of appointment was issued to Sh. AVINASH VERMA on 28.04.2023 and was called for document verification on 01.05.2023.

And Whereas, further a deficiency memo no. 131 dated 05.04.2024 was issued to Sh. Avinash Verma to submit the NCL certificate before cut-off date. In response to the said memorandum he again submitted an affidavit in which he declare that "I have obtained the DELHI OBC CERTIFICATE bearing no. 90500000639874 certificate dated 29/06/2020. That I declare when the certificate was issued in 2020, I was in non creamy layer Criteria. That I was unable to apply non creamy layer certificate at that time due to Covid Pandemic."


And Whereas, further a deficiency memo no. 150 dated 01.05.2024 was issued to Sh. Avinash Verma to submit the OBC certificate before cut-off date. In response to the said memorandum the candidate did not submit the requisite document i.e. OBC certificate before the cut-off date as mentioned above. However, the candidate vide PUC no. 4541 dated 08.05.2024 has enclosed the affidavit submitted by the candidate earlier in this office, wherein, it has been stated that "That I have applied for OBC certificate in the month of February & got acknowledgement as well as certificate no. on 21/02/2020 & due to COVID-19 no public dealing my OBC certificate issued on 29/06/2020."

And Whereas, since despite of submitting OBC certificate issued before cut-off date, the candidate is stating that he had applied for OBC certificate in month of February and due to COVID-19 OBC certificate was issued on 29/06/2020 (i.e. after cut-off date).

And Whereas, As per the DSSSB Advt. 02/2020, the reservation benefits Candidates who wish to be considered against reserved vacancies and /or to seek age relaxation, must be in possession of relevant certificates (EWS/SC/ST/OBC/NonCreamy layer/PwD/Educational/Experience etc.) issued by the competent/notified authority (in prescribed format) on or before the cutoff date (closing date of advertisement) otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies, if eligible otherwise. The candidate has to select that particular category when applying online for the Post. No request for change of Category will be entertained at any later stage.

Therefore, in view of the facts and circumstances as above and since the candidate failed to submit OBC certificate issued before cut-off date i.e. 22/02/2020 of DSSSB Advt. no. 02/20, the candidature in respect of **Sh. AVINASH VERMA**, D.O.B. **24/09/1982**, Roll No. **112302800135** for the post of PGT (Maths) Male against Post Code 28/20 is hereby **cancelled** and his dossier returned to the DSSSB.


