**MEMORANDUM OF CANCELLATION**

**Subject:- Cancellation of candidature of Shri Sushil Thakran to the post of GRADE-IV DASS/LDC (under Post Code-68/12).**

Whereas, on the recommendations of Delhi Subordinate Service Selection Board (DSSSB) to the post of GRADE-IV DASS/LDC, (Roll No.20012518), Post Code 68/12 and nominated by Services Department (III) in the Directorate of Education, GNCT of Delhi; offer of appointment was issued F.DE.1(7)/A/E-I/216/LDC/2016/6533-35 dated 21/07/2016 to Shri Sushil Thakran (D.O.B.: 11/10/1986) S/o Sh. Satya Dev, R/o House No.- 302, Village Bajitpur, Post Nangal Thakran, Delhi-110039.

And Whereas, Shri Sushil Thakran vide form for verification of Character & Antecedent informed that a FIR No. 307/10 u/s 392/498-A/406/506/34 IPC in Police Station Alipur, Delhi is registered against him. Therefore, his dossier was returned to the Cadre Controlling Authority i.e. Service Department, GNCTD for further necessary action vide this office letter no. 2766-67 dated 28.04.2017.

And Whereas, Shri Sushil Thakran challenged the aforesaid order dated 28.04.2017 in Hon'ble CAT vide O.A. NO.100/4433/2017. Hon'ble CAT disposed said OA vide order dated 03.08.2023 and ordered that :-

*"10. In view of the observations recorded herein above, the present OA is allowed. The impugned order dated 28.04.2017 is quashed and set aside with a direction to the respondents to consider the case of the applicant and issue the offer of appointment to him, subject to his meeting other eligibility criteria to the post of Grade (IV) DASS/LDC with all consequential benefits albeit on notional basis.*

*11. However, it is made clear that in case the outcome of FIR is against the applicant, the applicant shall not stake his claim on the said appointment and he will be required to face necessary consequences of the same as per law."*

And Whereas; in compliance of order/direction of Hon'ble CAT; the matter/file of appointment of Shri Sushil Thakran to the post of Grade-IV(DASS)/LDC was considered & processed and dossier of Shri Sushil Thakran was scrutinized. A Deficiency Memorandum dated 04/01/2024 was sent (via Speed Post, e-mail & Edudel MIS Portal) to the candidate i.e. Sh. Sushil Thakran for removal of following discrepancies:-

1. Fresh Character and Antecedent form.
2. Relieving order of Centre/State Government, if applicable.
3. Undertaking to inform in the office about every proceedings/outcomes of Court Case/FIR No. 307/10 u/s 392/498-A/406/506/s34 of IPC in Police Station Alipur, Delhi.
4. Four recent passport size photographs, duly self attested.
5. All original educational/technical qualification certificates/Degrees and mark sheets in original along with one set of self certified copies.
6. All original certificates regarding date of birth, educational qualification etc. (including certificate belonging to Scheduled Caste/Tribes/OBC/ PH/Sports Quota/Ex-Service Man etc. wherever applicable).
7. Latest Non Creamy layer Certificate (if applicable).
8. SC/ST/OBC/PH/Sports Quota/Ex-Service Man etc. wherever applicable; certificate in original along with self attested copy (if applicable).
9. Declaration about marital status and in the event of his having more than one living wife, his appointment will be subject to being exempted from the enforcement of the rule in this behalf.

And Whereas; Shri Sushil Thakran reported to E-I Branch (HQ) on 18/01/2024 and submitted records/documents for the said Deficiency Memorandum (only for points 01, 03, 05, 06, 08 & 09) but he did not provided/submitted records/documents for deficiencies mentioned at points 02, 04 & 07.

And Whereas, Shri Sushil Thakran vide his Fresh Character and Antecedent Form mentioned that he is presently working on the post of Asstt. Teacher (Primary) in Directorate of Education, GNCT of Delhi in S(Co-Ed) Vidyalaya, Gulabi Bagh-1208013.

And whereas; a Deficiency Memorandum Reminder-I dated 06/02/2024 was sent (via Speed Post, e-mail & Edudel MIS Portal) to Shri Sushil Thakran. He reported to E-I Branch, Directorate of Education on 19/02/2024 and submitted latest Non Creamy Layer Certificate but again did not remove the deficiencies mentioned at points no. 02 & 04.

And Whereas; 2<sup>nd</sup> Deficiency Memorandum Reminder-II dated 15/03/2024 was sent (via Speed Post, e-mail & Edudel MIS Portal) to the candidate i.e. Shri Sushil Thakran, for which he reported to E-I Branch (HQ) on 09/04/2024 wherein he removed deficiency mentioned above at point no. 04 but again he failed to removed the deficiency mentioned at point no. 02 i.e. Relieving order of Centre/State Government, if applicable.

And Whereas; after seeking approval of the Competent Authority, Last & Final Reminder vide Deficiency Memorandum dated 26/04/2024 was sent (via Speed Post, e-mail & Edudel MIS Portal) to the candidate i.e. Shri Sushil Thakran for submitting his relieving order from the post of Asstt. Teacher (Primary), Directorate of Education, GNCT of Delhi, in this office within 15 days; failing which his candidature as well as offer of appointment for the post of Grade-IV (GNCTDSS)/LDC (under Post Code-68/12) will be cancelled and his dossier will be returned to Services Department, GNCT of Delhi, without any further communication to him. However, no information/intimation/reference to Final Deficiency Memorandum reminder/notice dated 26.04.24 is received from Shri Sushil Thakran so far.

And whereas, the matter was placed before the Competent Authority i.e. Worthy Director, Education, GNCT of Delhi. The Competent Authority has approved for cancellation of the candidature of Shri Sushil Thakran for the post of Grade-IV(DASS)/LDC under post code of 68/12 and to return his dossier to Services Department, GNCTD.

Therefore, the offer of appointment dated 21/07/2016 issued to Shri Sushil Thakran for the post Grade-IV(DASS)/LDC under post code of 68/12; is hereby withdrawn and his candidature stand cancelled and his dossier is being returned to Services Department, GNCTD for further necessary action at their end.

**"No claim for appointment, if so, made at any later stage on the basis of any ground by the candidate will be entertained by this department, in future."**

This issues with the prior approval of the Competent Authority.


