ORDER

Cancellation of Candidature for the post of Domestic Science Teacher, under post code-88/20

Whereas, Ms. Srishti Singh, DOB- 03.06.1996, Roll No. 111508800018, Selection Category-UR was provisionally nominated by DSSSB for the post of Domestic Science Teacher, under post code- 88/20 in Directorate of Education, Govt. of NCT of Delhi vide result notice no. 87 dated 05/01/2022 and accordingly offer of appointment was issued to her vide No. F.DE.4 (32)/DRC/E-IV/DST(88/20)/2022/6457 dated 17.10.2022.

And Whereas, after document verification, a deficiency memorandum was issued to Ms. Srishti Singh, DOB- 03.06.1996, Roll No. 111508800018, Selection Category-UR with the direction to submit the requisite documents/clarification regarding Domestic Science/Home Science as a teaching subject in B.Ed and original B.Ed degree within 15 days from the date of issuance of this letter.

And Whereas, Ms. Srishti Singh has submitted clarification regarding Home Science as teaching subject in B.Ed by providing Admit card as well as clarification certificate (To whom it may concern) which is issued by Controller of Examination, Babasaheb Bhimrao Ambedkar Bihar University, Muzaffarpur, Bihar.

And Whereas, Ms. Srishti Singh has also submitted her reply with regard to deficiency memo regarding original degree that preparation of original certificate is under process and requested for consideration of provisional certificate till the original certificate are received.

And Whereas, an Expert Committee was constituted to discuss the matter regarding consideration of the candidate nominated by DSSSB for the post of Domestic Science Teacher under post code 88/20 with reference to Notified Recruitment Rules vide order No. 4(32)/DRC/E-IV/DST(88/20)/2022/Pt.file/Vol.II/991-1001 dated 15.11.2023. The Committee in its meeting held on 14.12.2023 recommended for the appointment of Ms. Srishti Singh. The recommendation made by Committee has been considered by the Competent Authority i.e. the Director of Education.

And Whereas, appointment order was issued to Ms. Srishti Singh, Employee I.D. 20240159 vide order dated 27.03.2024 with the direction to report to her respective place of posting latest by 26.04.2024, failing which her appointment shall be stand cancelled without any further communication.

And Whereas, Ms. Srishti Singh, Emp. I.D. 20240159 failed to join respective place of posting latest by 26.04.2024. Subsequently three reminders dated 31.05.2024, 18.06.2024 and 09.07.2024 (Final Reminder) were also issued by giving last opportunity to join her place of posting within 07 days from the date of issuance of the reminder, otherwise, the candidature for the said post will be cancelled without any further notice and her dossier will be returned to DSSSB. No further communication will be entertained in this regard. **However, Ms. Srishti Singh, Employee I.D. 20240159 has not joined her duties till date.**

Therefore, on the above facts and circumstances the appointment order no. DE4(32)/DRC(E-IV)/DST(88/20)/2022/Pt.file-I/1258, Posting ID-20240049, dated 27.03.2024 as well as offer of appointment no. F.DE.4 (32)/DRC/E-IV/DST(88/20)/2022/6457 dated 17.10.2022 issued to **Ms. Srishti Singh, Employee I.D. 20240159 is hereby withdrawn and candidature stands cancelled.**
