**ORDER**

This is in continuation to the Public Notice No. F.16/DDE(IEB)/Admn.Cell/Pt. File/2019/657-664 dated 16.01.2023 regarding drawing a panel of candidates for engagement as Special Educator (Primary) (Guest) in schools of Delhi.

Further, the candidates mentioned in **Annexure-I** have already been issued engagement order but could not join earlier due to various reasons. The terms and condition for engagement of candidates in Govt. Aided Schools shall remain the same as that of the Guest Teachers in Directorate of Education, GNCTD. In addition to above, Manager/HOS, of these schools shall engage these candidates as Special Educator (Primary) (Guest) as per the circular No. F. DE.15/38/ASB/2021/103-109 dated 20.01.2021 (copy of the circular is given in **Annexure-II**).

In addition to above, the Hon'ble Supreme Court of India vide order dated 28.10.2021 in WP(C)132/2016 titled, Rajneesh Kumar Pandey & Ors Vs Union of India & Ors has directed State/Union Territories to initiate appointment process for filling vacancies for the posts so created for special teachers for being appointed on regular basis. Further, vide order No. F.146/DDE(IEB)/Admn.Cell/2021/2386-2392 dated 18.04.2024 **it has been clarified that concerned HoS shall ensure joining of the eligible candidates in their schools irrespective of whether facility of Primary wing/section is available in the school or not.** The Special Educator (Primary) (Guest) deployed in the schools shall work with Students with Disabilities enrolled at all levels in the school.

**All the candidates (as per Annexure- I) are directed to report to concerned HOS of the school within five working days**, failing which it shall be presumed that candidate is not willing to join his/her duty. HOS shall immediately inform IEB-HQ through mail regarding non-joining of candidates allotted within 5 days so that waitlisted candidates can be posted. The candidates are also directed to produce the following documents (in original and one self-attested photocopy) for verification by HOS:

1. Printout of online filed application form bearing signature and date.
2. 10th class mark sheet and certificate showing Date of Birth.
3. 12th Class Mark sheet and certificate.
4. D.Ed Special Education or equivalent qualification Mark sheet of every year and Diploma/provisional Certificate.
5. SC/ST/OBC/EWS certificate (if applicable), issued by the Competent Authority. In case of OBC, the OBC Certificate should be issued by GNCT of Delhi.
6. Disability Certificate (if applicable).
7. Valid CTET Certificate (Paper-I)
8. RCI Registration Certificate



9. Non creamy layer certificate for the year 2022-23 (in case of OBC candidates).
10. Two photographs
11. Photo Identity proof (Preferably Aadhar Card).
12. Address proof.

In addition to above, **concerned HOSs are also directed to carefully verify the above mentioned documents with original to ensure eligibility as per eligibility criteria/Recruitment Rules for the post.** The details of eligibility criteria/approved provisions of RRs of the post are given below:

1. XII<sup>th</sup> passed and Two year D.Ed. Special Education in any of the category of disability.  
or  
XII<sup>th</sup> passed and One year Diploma in Special Education (DSE) in any of the category of disability.  
or  
Diploma in Community Based Rehabilitation (DCBR) with 6 months Certificate course in Education of Children with Special Needs.  
or  
Post Graduate Diploma in Community Based Rehabilitation (PGDCBR) with 6 months Certificate course in Education of Children with Special Needs.  
or  
Diploma in Multi Rehabilitation Worker (MRW) with 6 months Certificate Course in Education of Children with Special Needs.  
or  
Junior Diploma in Teaching the Deaf.  
or  
Primary level Teacher Training course in Visual Impairment.  
or  
Diploma in Vocational Rehabilitation-Mental Retardation (DVR-MR)/Diploma in Vocational Training and Employment Mental Retardation (DVTE-MR) with 6 months Certificate course in Education of Children with Special Needs.  
or  
Diploma in Hearing Language and Speech (DHLS) with 6 months Certificate course in Education of Children with Special Needs.  
or  
XII<sup>th</sup> passed with any RCI recognized qualification of minimum one year duration and 6 months Certificate course in Education of Children with Special Needs.  
or  
Any other equivalent qualification approved by RCI.
2. Qualified in Central Teacher Eligibility Test (CTET) (Primary stage) conducted by Central Board of Secondary Education (CBSE). Relaxation upto 5% in the qualifying marks shall be allowed to candidates belonging to reserved categories such as SC/ST/OBC/PH in CTET.
3. Registration with Rehabilitation Council of India (RCI).

Further, in case candidate is not eligible as per eligibility criteria/Recruitment Rules, he/she may not be allowed to join and his/her case shall be referred to DDE (Inclusive Education Branch) through the concerned District office. The percentage of marks entered by the candidates on online application form and the percentage given in the result uploaded may vary, as best marks of 5 subjects in class 10<sup>th</sup> & 12<sup>th</sup> and in diploma core subject have been taken for calculation of percentage in final result.



However, as per instructions issued in previous Public Notice candidates who have requested for the change/correction in marks/percentage, category, name or any other details have been rectified in the final merit list based on the representation, testimonials/documents provided by the applicants. Further, these changes have been mentioned in the final merit list as well as in this order and shall be considered as final subject to production of original documents at school level.

In case any clarification is required regarding eligibility criteria/Recruitment Rules for the concerned post then the HOS may consult and seek advice of the DDE, Inclusive Education Branch.

In addition to above, the arrangement is purely temporary in nature and will not confer upon him/her any right whatsoever for regular appointment or placement in any other Department under the Govt. of NCT of Delhi or otherwise.

Sub:- Providing Guest Teacher in Govt. Aided Schools.

It has been decided to deploy Guest Teachers in Government Aided School as a temporary measure till the vacancies in these schools are filled through Direct Recruitment /Promotion. The following terms and conditions has been laid down in this regard :-

1. The Management Committee has to submit a formal request for deployment of Guest Teachers in their aided school against the vacant post of the concerned subject.
2. The Management Committee must agree to pay 5% of their share towards payment of salary to the Guest Teachers.
3. A list of subject wise Guest Teachers will be provided by E-V Branch through ASB Branch to the Govt. Aided School as per their requirement.
4. Deployment of Guest Teacher is temporary arrangement till the posts are filled on regular basis in their respective school.
5. Other terms and conditions of deployment of Guest Teacher in Government Aided School shall be same as on the terms and conditions of government schools.
