ORDER

Cancellation of Candidature for the post of Assistant Teacher (Primary)-42/21

Whereas, Mr. Amit Malik (DOB: 07.07.1989, Roll No. 112704200198, Sel. Cat. – UR/GCT) was provisionally nominated by the DSSSB for the post of Assistant Teacher (Primary) under the post code 42/21 vide letter No.F.DE.4(49)/DRC/E-IV/PRT(42/21)/2023/1662 dated 23/12/2022 (as per vacancy advertisement no. 02/21) by the selection mechanism authority i.e., DSSSB vide result notice No. 1489 dated 02.11.2022 and he was called for document verification vide Office Memorandum No.F.DE.4(49)/DRC/E-IV/PRT(42/21)/2023/5654 dated 02.05.2023. During the document verification held on 15.05.2023, the candidate has been found overage by 01 year, 11 months and 17 days and he requested age relaxation being a Guest Teacher in Department of Directorate of Education.

And whereas, the candidates was given deficiency as “Deficient on Age relaxation as on cut-off date as he was not on Service on cut-off date” vide letter even no 63 dated 15.05.2023.

And whereas, in response of the deficiency, he submitted the experience certificate being a guest teacher employed on the Department of Directorate of Education but failed to prove that he was on Service as a guest teacher on cut-off date i.e. 04.07.2021.

And whereas, as per the sub clause 2.iii of O.M vide letter even no. 1751-1756 dated 11.06.2019 regarding relaxation in upper age limit to the contractual employees working under Government of NCT of Delhi at the time of regular appointment on direct recruitment basis ***“The contractual employees, working at the time of applying for direct recruitment, shall only be considered eligible for relaxation in upper age limit”***.

And whereas, a proposal was referred to Service Department for a consideration to relax the condition of working as contractual employee at the time of applying for direct recruitment to the extent to allow age relaxation to those candidates, who were not working as guest/contract teacher but were on a panel for re-engagement at the time for direct recruitment in the context of teaching posts under Directorate of Education.

And whereas, Services Department vide note bearing F.10 (110)/S-IV/Advice/Shadow File/Edu. Deptt./2018/1159 dated 08.08.2024 has conveyed that

the proposal of the Education Department to relax sub clause (iii) para 2 of O.M dated 11.06.2019 shall not be accede to.

Keeping in view of the above facts & circumstances, the offer of appointment issued to the candidate is hereby withdrawn and the candidature of the above candidate stand cancelled accordingly with retrospective date of offer of appointment, issued to the candidate. The concerned E-dossier file is being returned to DSSSB for further necessary action at their end.

"No claim for appointment, if so, made at any later stage on the basis of any ground by the candidate will be entertained by the department, in future."

This issues with the prior approval of the competent Authority.
