Consequent upon nomination through Delhi Subordinate Services Selection Board for the post of TGT HINDI (FEMALE) vide letter No.F.1 (193)/DSSSB/ P&P/13/Part File-II/2104 dated 22.08.2024 and in compliance of order of Ld. CAT in O.A. No. 45782/2014, followed by Hon'ble High Court of Delhi's order dated 21.02.2024, in WP(C) No. 10718/2016, titled as Devender Yadav & Ors Vs Secretary, DSSSB & Ors and subsequently upheld by Apex Court vide SLP No. 7954/2024 dated 29.04.2024 & further subject to outcome of SLP to be filed by DSSSB before Hon'ble Supreme court against the order dated 13/05/2024 of Hon'ble High Court Delhi in the matter of DSSSB Vs Amit Kumar & Ors vide W.P. (C) No. 6802/2024" and with the prior approval of the Competent Authority, the following candidate is hereby appointed purely on Temporary and provisional basis, for the post of TGT- Hindi (Female) vide advertisement no. 01/13 & post code 07/13 in the pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4600 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by her. The candidate has been medically examined by the Govt. Hospital and declared FIT and his individual report placed in his respective dossier. Subsequently, the OBC/NCL verification report will be checked by the DDE concerned. If the OBC certificate of the candidate concerned is found invalid, her candidature will be terminated with immediate effect. The candidate is hereby directed to report to his respective place of posting latest by 18.12.2024 failing which her appointment shall stand cancelled without any further communications. (iii) Verification of recognition of institute/university and NCTE, from which the candidate has acquired his degree and on which they rely upon for the said post. (iv) Biometric/Photograph/Manuscript Verification of the candidate. This issue with the prior approval of the Competent Authority.


