ORDER

REJECTION/CANCELLATION OF CANDIDATURE IN R/o Mr. GURVINDER SINGH ANAND FOR THE POST OF TGT PUNJABI (MALE) UNDER POST CODE 56/21.

Whereas, Mr. Gurvinder Singh Anand, D.O.B 11.03.1986, Roll No. 112405600045 has been provisionally nominated & selected by the DSSSB for appointment to the post of TGT PUNJABI (Male) Post Code 56/21 under OBC category in Directorate of Education, Govt. of NCT of Delhi.

And Whereas, Mr. Gurvinder Singh Anand was not working as Guest Teacher as on cutoff date i.e. 03.07.2021 extended dated 10.07.2021 at the time of applying for the post of TGT (Punjabi) Male and hence does not fulfill the conditions of advertisement 03/21 for age relaxation.

Further, a proposal was referred to Services Deptt. for a consideration to relax the condition of working a contractual employee at the time of applying for direct recruitment to the extent to allow age relaxation to those candidate, who were not working as guest/ contract teacher but were on panel for re-engagement at the time of applying for direct recruitment in the context of teaching posts under Directorate of Education.

Now, Services Deptt. vide note bearing No. F.10(110)/S-IV/Advice/Shadow file/Edn. Deptt./2018/1159 dated 08.08.2024 has conveyed that the proposal of the Education Deptt. to relax sub-clause (iii) para 2 of O.M. dated 11.06.2019 shall not be acceded to.

Therefore, in view of the above facts and circumstances, the candidature of Mr. Gurvinder Singh Anand, D.O.B 11.03.1986, Roll No. 112405600045 for the post of TGT PUNJABI (Male), Post Code 56/21 of DSSSB Advertisement vide NO. 03/2021 under OBC category is hereby rejected/cancelled as the candidate was not working as Guest teacher on cut-off date i.e. 03.07.2021 extended date 10.07.2021 at the time of applying for the post of TGT (Punjabi) Male and hence does not fulfill the condition of Adv. 03/21 for age relaxation and his e-dossier returned to the DSSSB, GNCTD.

This issues with the prior approval of the Director (Education).
