ORDER

**REJECTION/ CANCELLATION OF CANDIDATURE IN R/O EKATA SHARMA FOR THE
POST OF TGT (SANSKRIT) FEMALE UNDER POST CODE-55/21**

Whereas, Ms. Ekata Sharma, D.O.B. 30.10.1976, Roll No. 325055100186 has been provisionally nominated & selected by the DSSSB for appointment to the post of TGT SANSKRIT (Female) post code 55/21 under UR category in Directorate of Education, Govt. of NCT of Delhi and she was called for document verification vide this Office memorandum no.: F.NO. DE.3(42)/DRC/E-III/TGT/SANSKRIT(FEMALE)/2022/7820 dated 11.11.2022 to submit her acceptance.

Whereas, in response to this, the said candidate reported at scheduled date & time of DV and accepted the offer of appointment.

And whereas, Ms. Ekata Sharma was called for verification for their documents and on verification it was found that Ms. Ekata Sharma submitted her age relaxation certificate issued from Deputy Director of Education, Samagra Shiksha-Delhi wherein it is certified that she has worked as Upper Primary Teacher on contractual basis for different periods from 1/11/2014 to 19/01/2021.

And whereas deficiency memo was issued vide letter No. DE.3(42)/DRC/E-III/TGT/SANSKRIT (FEMALE)/2022/375 on 17.11.2022 and the reply submitted by the candidate is not upto the merit as Ms. Ekata Sharma was not fulfilling the conditions of teaching as contractual employee at the time of applying for direct recruitment for the post of teaching category which is one of the main conditions for considering age relaxation under GCT category.

And whereas, as per the policy for relaxation of upper age limit for contractual employee circulated by file number F.19(11)/2015/S-IV/1751-1756 dated 11.06.2019 as per the letter under reference point no. 03 stipulate that:

“the contractual employees, working at the time of applying for direct recruitment, shall only be considered for relaxation in upper age limit”.

And whereas, since, Ms. Ekata Sharma was not fulfilling the above-mentioned condition for granting age relaxation in upper age limit, the case alongwith other similar cases were referred to services Department for considering the relaxation in upper age limit in r/o the candidates belonging to the various category for the post of TGTs which also include the case of Ms. Ekata Sharma for the post of TGT-Sanskrit (Female), post code 55/21.

And whereas, as per para 2 (iii) of OM dated 11/06/2019 issued by Services Department regarding relaxation in upper age limit to the contractual employees working under Government of NCT of Delhi at the time of the regular appointment on direct recruitment basis wherein clearly mentioned that :


“The contractual employees, working at the time of applying for direct recruitment, shall only be considered eligible for relaxation in upper age limit.”



And therefore, the candidature of Ms. Ekata Sharma, D.O.B. 30.10.1976, Roll No. 325055100186 for the post of TGT (Sanskrit) Female, post code 55/21 nominated by DSSSB under UR category vide result notice no. 167 dated 16.08.2022 is hereby Rejected/Cancelled as Ms. Ekata Sharma who was not working as contractual employee at the time of applying for direct recruitment.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."

This issues with the prior approval of the Director (Education).
