ORDER

Hon'ble Lt.Governor of Delhi is pleased to order that Shri K. Sambhamurti, Superintending Engineer (Civil)/Superintending Surveyor of Works (Civil) and Shri V.K. Jain, Superintending Engineer (Civil)/ Superintending Surveyor of Works (Civil) shall hold the Current-Duty Charge of the posts of Chief Engineer -I and Chief Engineer-II respectively in Irrigation and Flood Control Department, in addition to the duties already assigned to them as S.Es. (Civil), in terms of provisions contained under FR 49 (v).

(2) While holding the post of Chief Engineer-I and Chief Engineer-II on Current-Duty Charge basis respectively, Shri K.Sambhamurti, Superintending Engineer/SSW(Civil) and Shri V.K. Jain, Superintending Engineer (Civil)/SSW(Civil) will exercise all administrative, technical and financial powers and perform other non-statutory/routine duties of the post of Chief Engineer as per CPWD Manual/Code. However, the statutory powers of the post of the Chief Engineer as the Disciplinary Authority/Appellate Authority/Revisionary Authority under the CCS(CCA) Rules, 1965 and the powers of Head of the Department of Irrigation and Flood Control Department under the Delegation of Financial Powers and Rules (DFPR) will be exercised by the Secretary (I&FC) till the posts of Chief Engineers are filled on regular basis.

(3) It is further ordered that Shri K. Sambhamurti, Superintending Engineer (Civil) holding the Current-Duty Charge of the post of Chief Engineer (Zone-I) will co-ordinate with I&FC Secretariat and various other Departments/Agencies/Local Bodies of GNCT of Delhi and Govt. of India for all affairs of the I&FC Department.

(4) No additional pay/remuneration shall be admissible to Shri K. Sambhamurti, Superintending Engineer (Civil) and Shri V.K. Jain, Superintending Engineer (Civil) for holding the Current-Duty Charge of Chief Engineer-I and Chief Engineer-II respectively irrespective of the duration of the additional charge, as provided under FR 49 (v).

(5) With the issuance of this order Shri M.C.T. Pareva, will cease to hold additional charge of Chief Engineer, Irrigation & Flood Control Department with immediate effect.

These orders will remain operative till further order.
