OFFICE ORDER

In pursuance of Gazette Notification no. F.1/31/1169/LC/Estt./2023/5774-5784 dated 21/11/2023 and Gazette Notification no. F.1/31/1169/LC/Estt./2023/5762-5773 dated 21/11/2023, and in supersession of all previous orders, the work distribution among Dy. Electrical Inspectors and Assistant Electrical Inspectors, as detailed below is hereby ordered with immediate effect:-

Under the Electricity Act, 2003 :-

The above mentioned officers will carry out the initial inspections under the provision of the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2023. The above mentioned DEIs shall also function as Enquiry Officers under the conditions for the grant of Certificate of Competency to Electrical Supervisor, Electrician and Licenses to Electrical Contractors, 2016 in their concerned districts. They shall also deal with the cases of NHRC/PGMS/RTI/DERC/all court matters in their respective districts.

The work distribution among the Assistant Electrical Inspectors for periodical inspection of the electrical installation under the provisions of the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2023 is as follows:-

Further, the above mentioned AEIs shall also function as Issuing Authority under the conditions for the grant of Certificate of Competency to Electrical Supervisor, Electrician and Licenses to Electrical Contractors, 2016 in their concerned districts.

In respect of matters of electrical installation of accidents sites vide this department order No. F. No. F/31/125/LC/Esstt./12/IV/717 dated 11/7/2017; the concerned district Electrical Overseer will carry out the inspections as directed by the District AEI. The concerned district AEI shall mark the request/intimation letter to the concerned Electrical Overseer for inspection. After inspection, the Electrical Overseer shall submit the technical inspection report to the concerned district AEI for further necessary action. As and when required and directed by Incharge of Electrical Inspectorate, electrical installation of accidents sites may also be inspected by the concerned district AEI/DEI, keeping in view the seriousness of the matter.

The Electrical Overseers posted in the districts will assist the concerned DEI/AEI of the respective districts. The Electrical Overseers will report to Assistant Electrical Inspector and Asstt. Electrical Inspector will report to Dy. Electrical Inspector.

Sh. Pulkit Yadav, Electrical Overseer, Sh. Umesh Kumar Rai, AEI and Dr. A.V. Koteswara Rao, DEI will also look after the work of Headquarter (Electrical Inspectorate).

Sh. Mukesh Kumar Sharma, DEI will continue to be the Incharge, Electrical Inspectorate.
