The following functions/duties are assigned to Sh. K.M. Singh, Joint Labour Commissioner:-



6. Monitoring of Pencil Portal with the coordination of District In charges. Weekly report to be submitted to Additional Labour Commissioner.
7. Revamping of existing Delhi web portal of Labour Department and in accordance with the latest technology and as per the GIGW, WCAG and developed in Bilingual.
8. Supervision of the field work in "All India Quarterly Establishment based Employment"(AQEES) at HQ Level.
