ORDER

Whereas, SBI Employees Cooperative Group Housing Society Ltd., Road No. 42, Bank Vihar, Pitampura, Delhi-110034, is registered with this Department vide Regn. No. 581/GH.

And whereas, Sh. Omkar Singh, Retd, DANICS was appointed as Administrator vide order dated 17/07/2023 u/s 35(5) of DCS Act, 2003, However he failed to get the pending audit of the society conducted. Further the election process was also not initiated.

Now, therefore, I, Surinder Narang, Asstt. Registrar/Link Officer (Section-VII/Housing), O/o RCS do hereby convey the approval of the Registrar Co-operative Societies to appoint **Sh. Lal Singh, Retd. ADM, GNCTD**, as Administrator in the aforesaid society u/s 35(5) of DCS Act, 2003 to manage the day-to-day affairs of the society and also to conduct election in the Society within a period of ninety days from the date of his appointment. The Administrator shall draw a sum of Rs.10,000/- (Rs. ten thousands only) per month as honorarium alongwith conveyance charges out of the society funds.

The other expenses of the election will be met out from the funds of the society. The election of the Managing Committee of the aforesaid society shall be conducted as per the guidelines for the elections laid down in Rule 53 and of Schedule-II of DCS Rules, 2007.

Further, the Ex-President/Ex-Secretary/Ex Administrator-Cum-R.O., MC members of the society are hereby directed to handover all the records/documents of the society to the Administrator within 05 days from the date of receipt of this order.
