ORDER

Whereas, Holtec CGHS Ltd. is registered vide Registration No. 683/GH, Plot No. 2, Sector-09, Dwarka, New Delhi-110077 with this department under the provisions of DCS Act/Rules & Registered Bye-Laws of the society.

And whereas, a complaint has been filed by 35 members/residents of the society against the Management Committee of the society alleging that the M.C is not making available the documents related to membership like Electricity Bills, Accounts, Open Parking, By Laws, Amended By Laws (if any), member list and Minutes of M.C meeting (copy enclosed).

And whereas, vide order dated 04.10.2022 an Inspection Officer under section 61 was appointed to inspect the records of the society in r/o allegations levelled against the then M.C. of the society and submitted his report on dated 23.08.2023 (copy enclosed).

And whereas, the inspection report was sent to M. C of the society for their comments vide this office letter dated 27/09/2023 and M.C of society submitted their reply vide letter dated 21.10.2023 (copy enclosed).

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (Sec-III/GH) hereby convey the approval of the Competent Authority to appoint Sh. Ashish Kumar, Dy. Secretary (AR Department), as an Inquiry Officer under Section 62 of DCS Act, 2003 in Holtec CGHS LTD., Plot No. 2, Sector-9, Dwarka, New Delhi-110077 (Regn. No.683/GH) to inquire into the allegations mentioned in the complaint dated 10.09.2022 and subsequent inspection report dated 23.08.2023 against M.C of Holtec CGHS Ltd. The Inquiry of the same shall be completed within a period of 60 days of issue of this order.

The Inquiry Officer will be paid Rs.15,000/- (Rupees Fifteen Thousand Only) as Honorarium from the society's funds.
