Whereas, The Vaish Cooperative New Bank Limited, H.O.: 7-B, Netaji Subhash Marg, Darya Ganj, New Delhi-110002 (*hereinafter referred to as 'Society'*), is registered with this department under the provisions of Delhi Cooperative Societies Act, 2003 (*hereinafter referred to as 'Act'*) and rules framed thereunder.

Vide letter dated 16.12.2023, The General Manager of the society requested this office to appoint a Returning Officer to conduct the election of the Managing Committee of the society u/s 35 (1) at the earliest. The last election of the society was held on 11.04.2021.

Now therefore, I, Surinder Narang, Assistant Registrar (Banking) O/o RCS, hereby convey the approval of the Competent Authority to appoint Sh.
