**ORDER**  
**U/s 35(1) of DCS Act 2003**

Whereas, Maa Jhandewali Cooperative Urban Thrift & Credit Society Ltd. (hereinafter referred to as "Society") 145, DDA Office Complex, C.M., Jhandewalan Extension, Phase-I, New Delhi - 110055, is registered with this department under the provisions of Delhi Cooperative Societies Act, 2003 and Rules framed thereunder.

Whereas, complaints have been received from the members of the Society and also from Director-Cum-Joint Secretary of the Society that the existing Managing Committee of the Society is tempering official records, using society's funds in wrong manner and is not following the DCS Acts & Rules and a serious concern was also raised that the result of forthcoming election may be manipulated by the existing managing committee to achieve the result in favour.

Whereas, the proviso appended with Section 35(1) of DCS Act, 2003 provides that in case of dispute in a society, the Registrar may appoint the Returning Officer to conduct the election of a society.

Now therefore, in exercise of the powers conferred u/s 35(1) of DCS Act 2003, the Registrar Cooperative Societies is pleased to appoint Shri Bajrang Lal, DANICS (Retd.) as Returning Officer for holding the election of the Managing Committee of the Society within ninety days as per the provisions of the DCS Act, 2003 and rules framed thereunder.

Sh. Bajrang Lal, DANICS (Retd.) shall be paid a sum of Rs. 10,000/- (Rs. Ten Thousand only) for the conduct of election from the funds of the Society.
