

ORDER UNDER SECTION 91 OF DCS ACT 2003

1. By this Order I shall dispose off the appeal dated 27.06.2023 under section 91 of DCS Act 2003 filed by the appellant against the respondent society for non response by the society in respect of application for transfer of membership submitted by the appellant through Office of Registrar Cooperative Societies due to non acceptance of the application by the society..


BRIEF FACTS OF THE CASE:-

2. An appeal dated 27.06.2023 has been filed by the appellant Shweta Bhardwaj Dixit against the respondent society Jyoti CGHS Ltd., The appellant has stated that it approached the President/Secretary for submission of application of transfer of membership in her name u/s 91 of DCS Act 2003 number of times but they refused to accept the application on vague grounds. The appellant was left with no option and she submitted her application in RCS Office vide dairy No.: 3227 dated 20.01.2023 along with original documents and original DD

payable at Axis Bank, Delhi. copies of documents have been annexed with the appeal. The appellant received a letter dated 23.02.2023 from the Office of Registrar Cooperative Societies directing the President/Secretary to look into the matter and do the needful as per the bye-laws of the society and submit the action taken report within 7 days from the date of receipt of letter, copy of the letter is annexed with the appeal. Since the appellant did not receive any reply from the society it has filed an appeal dated 27.06.2023.

3. Notices dated 26.09.2023 and 16.11.2023 were issued for appearances on 20.10.2023 and 23.11.2023. The case was heard on 20.10.2023, 23.10.2023 and 23.11.2023. Arguments were heard on 23.11.2023 from both the parties.
4. The society did not raise any objection as regards the documents which they received from Office of Registrar Cooperative Societies for transfer of membership in favour of the appellant.
5. From the perusal of the copies of documents annexed by the appellant with the appeal, the appellant has applied with all requisite documents and affidavits and has paid the requisite amount of fees. Further the appellant has annexed a copy of registered Sale Deed registered on 05.09.2013.
6. All the conditions as required under the provisions of Section 91 of DCS Act 2003 are fulfilled in the present case.
7. No disqualification has been pointed out by the respondent society qua the appellant for her becoming a member of the society.
8. Transfer of Membership cannot be refused by a society without sufficient cause. The society does not have an unfettered right to admit, deny or refuse transfer of membership.
9. In view of the above, the respondent society is directed to transfer membership in the name of the appellant Shweta Bhardwaj Dixit i.r.o.
