ORDER

Sub: Withdraw/Cancellation of Notice of Special GBM dated to be held on 24.03.2024 issued on 12.03.2024.

It has come to the notice of the this Department has come to know that you have circulated a notice for calling a Special General Body Meeting (SGBM) on Sunday 24th March, 2024 at 11:30AM at the Society Office to elect a new Managing Committee whereas you are well aware that after the supersession of the Managing Committee u/s 37(1) of the DCS Act 2003, Sh. P.K. Khanna, DSP, CBI (Retd.) was appointed as an Administrator to manage the affairs of the society and now vide this office order no. F.47/331/HC/GH/Sec-VIII/2023-24/903-906 dated 19.02.2024 has been replaced by Sh. V. K. Rastogi who has already resumed his duties on 27.02.2024 and requested Mr. P.K. Khanna to handover the record of the society.

In the light of the above you have no right and authority to call SGBM as there is no recognised post of Advisor in the DCS Act 2003 and the rules made there under after joining Sh. V.K. Rastogi, Administrator appointed by this department. He has informed that he came to the society twice but you created hurdle in taking the charge of the society who is the public servant u/s 21 of the IPC whereas you have no locus standi being a non member in the society. At present only the authorised person appointed by this department is Sh. V.K. Rastogi who will manage all the affairs of the society with to form a local committee among the valid members of the society to manage the day to day affairs and to call the SGBM if requires. In case if you create any hindrance, you will be personally held responsible for all consequences. Hence, this notice is hereby cancelled and be treated as it has never been issued.
