**ORDER**

Whereas, The Dhan Sangrah Co-operative (U) Thrift and Credit Society Limited, 13/101-102, Kalyan Puri, Delhi- 110091 (*hereinafter referred to as 'Society'*), is registered with this department under the provisions of Delhi Cooperative Societies Act, 2003 (*hereinafter referred to as 'Act'*) and the rules framed thereunder.

Whereas vide letter dated 05.03.2024, the President of the Society informed that the Managing Committee (MC) has completed its three years term prescribed in the DCS Act, 2003.

Whereas, as per the records available, in the office of the Registrar Cooperative Societies, Delhi (RCS), the last elections of the Society were held on 28.12.2020. And, as such, the term of the MC has expired on 27.12.2023 and the existing MC has no statutory authority to operate Society and to conduct elections.

Now therefore, I, Surinder Narang, Assistant Registrar (Banking), hereby convey the approval of the RCS to appoint Shri A.K. Kaushal, DANICS (Retd.), as an Administrator-cum-RO of the Society, in terms of the Section 35(5) of the DCS Act, 2003. A sum of Rs.10,000/- (Rupees Ten Thousand Only) per month, will be paid to him towards remuneration, from the funds of the Society. He may hold the election, within a period of 90 days, from the date of receipt of this order.

The expenses for conducting the elections of the Society will be met out from the fund of the Society. The election of Managing Committee of the aforesaid society shall be conducted as per the provisions of the DCS Act, 2003 and the rules framed thereunder.

This issues with the prior approval of the RCS.
