35 (1)	All loans shall be granted within the maximum credit limit of a member at the discretion of the committee on security of one or more securities and shall not exceed ten times value of member's paid up share of Rs. 10,000/- (Rupees Ten Thousand Only/-).	All loans shall be granted within the maximum credit limit of a member at the discretion of the committee on security of one or more securities and shall not exceed ten times value of member's paid up share of Rs. 20,000/- (Rupees Twenty Thousand Only/-) i.e. Rs. Two Lakh Only.


