ORDER

Whereas, The Delhi State Co-operative Bank Limited (*hereinafter referred to as 'Bank'*), Head Office at 31, Netaji, Subash Marg, Daryaganj, New Delhi-110002, is registered at S.No. 1921, with this department under the provisions of Delhi Cooperative Societies Act, 2003 and Delhi Cooperative Societies Rules, 2007, and bye-laws of the Bank framed thereunder.

And whereas the last election of the Management Committee of the Bank were held on 05.02.2020 for a period of 03 years. As the term of the existing Managing Committee of the Bank has expired on 04.02.2023, the Secretary (Cooperation), GNCT of Delhi, appointed Sh. Ajay Arora (DANICS), SDM (Delhi Cantt), as Returning Officer u/s 35(1) of Delhi Co-operative Societies Act, 2003 vide this office order dated 02.02.2023 for holding the election of the Managing Committee of the aforesaid bank, as per the DCS Act, 2003 and Rules framed thereunder i.e. DCS Rules, 2007 and registered bye-laws of the said Bank.

Sh. Ajay Arora, SDM (Delhi Cantt) vide his letter dated 23.02.2023 resigned from the post of Returning Officer citing administrative preoccupations. The Hon'ble High Court of Delhi vide order dated 28.02.2023 in W.P.(C) No. 1072/2023 titled Delhi State Cooperative Bank Ltd. vs RCS directed to appoint Returning Officer (RO) within one week.

Thereafter, Sh. Vijay Singh Malik, DANICS (Ad-hoc), Deptt. of Education, was appointed as Returning Officer vide order dated 07.03.2023. Sh. Vijay Singh Malik vide his email dated 06.03.2024, has informed that the notification for the general parliamentary elections 2024 is likely to be issued and since he has been appointed as Assistant Returning Officer of the Parliamentary Constituency-01 Chandni Chowk (AC-22 Ballimaran), it is not possible for him to complete the election process of Bank, before the election of the general parliamentary elections 2024 is completed. He has requested the Registrar of Cooperative Societies that if the election process of the Bank is to be completed in the month of April 2024, he may appoint some other officer as Returning Officer in his place.

Now therefore, I, Surinder Narang, Assistant Registrar (Banking) O/o RCS, hereby convey the approval of the Competent Authority to appoint Shri A.K. Kaushal, DANICS (Retd.) as Returning Officer in terms of section 35(1) of DCS Act, 2003. A sum of **Rs. 10,000/- (Rupees Ten Thousand Only/-)** plus travelling allowance will be paid to him as remuneration from the funds of the society. The Returning Officer may hold election within a period of 90 days from the date of his appointment.

The other expenses of the election will be met out from the fund of the society. The election of the Managing Committee shall be conducted as per the DCS Act & Rules framed thereunder.

This issues with the prior approval of the Competent Authority.
