ORDER

Whereas, Rao Cooperative Group Housing Society Ltd., Plot No.2, Sector-23, Dwarka, Ph-I, New Delhi – 110075 is registered with this Department as per DCS Act & Rules and as per by laws of the society vide registration No. 1250(GH.)

Whereas, the Management Committee fails to conduct timely election of the new Management Committee before the expiry of its term i.e. on 24.01.2024 and the Management Committee loses its mandate to exercise any power regarding appointment of Returning Officer. The appointment of Mr. Moni Cinmoy as a Returning Officer vide society letter dated 05.02.2024 in the said society is illegal as per DCS Act & Rules. The Competent Authority in exercise of power vested U/s 35(5) of DCS Act, 2003 direct the society to stop the current election process of new management committee conducting by Mr. Moni Cinmoy, Returning Officer appointed by the society with immediate effect.

Now, therefore, in exercise of power vested U/s 35(5) of DCS Act, 2003 the Competent Authority (Registrar Cooperative Societies, New Delhi) is pleased to appoint Sh. Tariq Salam, Retd., Dy. Registrar, O/o RCS, as an Administrator-cum- Returning Officer with immediate effect to manage the affairs of the society and to conduct the election of the Managing Committee of the society within 90 days from the date of issue of this order as per DCS Act & Rules.

Sh. Tariq Salam, will also submit monthly progress report about the status of affairs of the society by 10th of every month. Further, Sh. Tariq Salam will be paid honorarium of Rs. 10000/-+ Conveyance per month from the society's fund.

This issues with the prior approval of the Competent Authority.
