ORDER

Whereas, Sweta G.K. Co-operative Thrift and Credit Society Limited, 8A/419, DDA Janta Flats, Trilok Puri, Delhi- 110091 (*hereinafter referred to as 'Society'*), is registered with this department under the provisions of Delhi Cooperative Societies Act, 2003 (*hereinafter referred to as 'Act'*) and rules framed thereunder.

Whereas the President of the Society, vide his letter dated nil (received under Diary No 11257 dated 12.03.2024), informed that the tenure of the existing managing committee (MC) has expired and requested to allow them to conduct election for the constitution of the new MC.

Whereas, Section 35(5) of the Act states that the committee shall arrange election of the new committee before the expiry of its term and in case the committee fails to do so, the committee shall cease to hold office on the expiry of its term and the affairs of the co-operative society shall be managed by an administrator appointed by the Registrar who shall also hold election within ninety days from the date of his appointment.

Now therefore, I, Surinder Narang, Assistant Registrar (Banking), hereby convey the approval of the competent authority to appoint Shri Rakesh Kohli, Sr. AO/ O/o the RCS, as Administrator-cum-RO of the Society, in terms of section 35(5) of the Act. A sum of **Rs. 10,000/- (Rupees Ten Thousand Only/-)** per month as remuneration plus conveyance allowance will be paid to him from the Society's fund. The Returning Officer may hold election within a period of 90 days from the date of his appointment.

The expenses for conducting the election shall be met out from the fund of the Society. The election of the MC of the Society shall be conducted as per the provisions of the Act read with rules and bye-laws framed thereunder.

This issues with the prior approval of the Competent Authority.
