Whereas, Indraprastha Sehkari Bank Limited, A-101, Wazirpur Group Industrial Area, Delhi- 110052 (*hereinafter referred to as 'Bank'*), is registered with this department under the provisions of Delhi Cooperative Societies Act, 2003 (*hereinafter referred to as 'Act'*) and rules framed thereunder.

The Chief Executive Officer of the Bank has informed vide letter dated 01.03.2024, that the last election of the society was held on 09.05.2021 and accordingly the term of the existing Managing Committee is expiring on 08/05/2024 and therefore, requesting to appoint an Returning Officer to conduct the election for the Constitution of the new Managing Committee.

Now therefore, I, Surinder Narang, Assistant Registrar (Banking) O/o RCS, hereby convey the approval of the Competent Authority to appoint Shri Ajay Arora, Deputy Secretary (AR, Deptt.) as Returning Officer in Indraprastha Sehkari Bank Limited, under section 35(1) of DCS Act, 2003 with remuneration of **Rs. 10,000/- (Rupees Ten Thousand Only/-)** from the society's fund. The Returning Officer may hold election within a period of 90 days.

The other expenses of the election will be met out from the fund of the society. The election of Managing Committee of the aforesaid society shall be conducted as per the provisions of the DCS Act, 2003 read with rules framed thereunder.
