In pursuance of Rule 19(2) of DCS Rules 2007, applications are invited from the General Public of Delhi who fulfill the conditions laid down in Rule 19 and 20 of DCS Rules, 2007 for filling up two vacancies in the NPSC Cooperative Group Housing Society Ltd Regn. No. 839(GH), Regd. Office: Plot 5, Sector 2, Dwarka, New Delhi 110075 which have arisen due to the expulsion of members.
