**ORDER**

Whereas, the Manocha Bandhu Cooperative Group Housing Society Ltd, Plot No 14, Phase-II, Vikas Puri, New Delhi-110018 is registered vide Registration No. 470/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

Whereas, it came into notice of this office, by the letter of Returning officer, about the deferment of election for new management committee in Manocha Bandhu Cooperative Group Housing Society due to non receipt of nominations for contesting election and forming a working RWA with nine (09) members voluntarily to take care of affairs of society.

And whereas, due to absence of elected managing committee in society Sh. V. S. Malik was appointed as Administrator u/s 35(5) of DCS Act 2003 vide this office order dated 22.09.2023 to manage affairs of the society as well as to conduct election for new management committee of society and vide order dated 12.03.2024 his tenure was extended for further 90 days which has already expired on 12.06.2024.

Now, therefore, the undersigned hereby convey the approval of the Competent Authority to appoint Sh. G. S. Aggarwal, Retd. DANICS as Administrator u/s 35(5) of DCS Act, 2003 in Manocha Bandhu Cooperative Group Housing Society Ltd., with immediate effect for 90 days to look after the day to day affairs of the society and to conduct elections for the new Management Committee of the society. He will also submit a monthly status report of the society in this office.

He will be paid Rs 10,000/- (Rs Ten Thousand Only) per month as honorarium plus conveyance charges from the society fund for this purpose.


