ORDER

Whereas, the Modern Cooperative Group Housing Society Ltd, Plot no 05, Sector 15, Rohini, New Delhi-110089 is registered vide Registration No. 397/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, Sh Suresh Chand, Grade-I (DASS)/FSO was appointed Administrator u/s 35(5) of DCS Act 2003 in Modern CGHS Ltd vide letter dated 08.08.2023 for 90 days in place of Sh B.S.Thakur, Retd DANICS and he assumed duties of society on 14.08.2023. His tenure as Administrator has been extended further time to time.

And whereas, vide letter dated 19.04.2024 the Administrator was directed to take necessary steps in order to complete the election in society within three months and submit monthly action taken report in this office but no effective steps has been taken by Administrator regarding conduct of elections in the society in order to form a democratic setup in society despite regular directions by this office.

Now therefore, the undersigned hereby convey the approval of the Competent Authority to appoint Sh Krishan Kumar, Special Secretary (PWD) as Administrator u/s 35(5) of DCS Act 2003 in place of current Administrator Sh Suresh Chand for 90 days with immediate effect with the direction to look after day to day affairs of the society and conduct elections for the new Management Committee of the society.

The Administrator will be paid Rs 10,000/- (Rs Ten Thousand Only) per month as honorarium plus conveyance charges from the society fund for this purpose.

This issues with the prior approval of Registrar of Cooperative Societies.


