ORDER

Whereas, the Media Cooperative Group Housing Society Ltd, Plot No. 18A, Sector-7, Dwarka, New Delhi-110075 is registered vide Registration No.1328/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, in Arbitration case No. 47/GH/DR/ARB/2021-22 titled R. Ramachandran & Ors Vs Media CGHS Ltd. & Anr, Ld Arbitrator vide Arbitration Award dated 09.01.2024, has held that the disqualification order of previous MC members, including the claimants by the RO on 15.09.2021 were illegal and consequently the election of MC of Media CGHS Ltd. held on 19.09.2021 is set aside. The Ld. Arbitrator further held that the election of the society be preponed and the RCS shall appoint an Returning Officer, who shall hold the election within 90 days from the date of his appointment. Till the election of the new MC, the present MC will continue to manage day to day affairs of the society, but will not take any policy decisions touching the management or business of the society.

Now therefore, the undersigned hereby convey the approval of the Competent Authority i.e. Worhty Registrar, Cooperative Societies to appoint Sh. Naveen Katarya, Dy. RCS (Rtd.) as Returning Officer u/s 35(1) of DCS Act 2003 in the Media Cooperative Group Housing Society Ltd, with immediate effect with direction to conduct elections of the Management Committee of the society within 60 days. He is directed to submit his report after the completion of election to the undersigned positively.

He will be paid Rs 10,000/- (Rs Tens Thousand Only) as honorarium plus conveyance charges from the society fund for this purpose.


