**Order under Section 139 of DCS Act,2003**

This order shall dispose of the appeal dated 10/04/2023 filed by Sh. Naresh Kumar, Flat No. C-12, Shivlok CGHS Ltd. Sector-6, Plot No.6, Dwarka, New Delhi-110075, who has sought information u/s 139 of DCS Act, 2003 vide his application dated 11/02/2023 from president/secretary, Shivlok CGHS Ltd. Sector-6, Plot No.6, Dwarka, New Delhi-110075. The appellant has stated that PIO of the society has not provided the desired information.

Hearings were conducted on 22/06/2023, 08/08/2023, 15/12/2023, 19/01/2024 and 01/03/2024.

It has been conveyed by the President/Secretary of the society vide his letter dated 16/02/2024, that he assumed the charge of office of the society on 15/10/2023, whereas the RTI dated 11.02.2023 and its subsequent appeal dated 10/04/23 u/s 139 of DCS Act-2003 were filed by the appellant during the tenure of the erstwhile Managing Committee.

In view of the above, as new M.C. has assumed the charge on 15/10/2023 and the appellant is also a member in the Managing Committee of the society, hence the appeal stand infructuous in light of the present facts, the respondent is hereby advised to obtain the requisite information from the President/Secretary of the society in accordance with Section 139 of DCS Act, 2003 read with Rule 165 of the DCS Rules 2007.

The Appeal is disposed of accordingly.
