**Sub:- Regarding proposal of Amendment of Bye-Laws in Ghalib Memorial CGHS Ltd.**

Sir,

With reference to your letter dated 13.10.2023 on the subject cited above, wherein the society has requested to amended Bye-Laws which registered with this office on 21.01.1977 under the DCS Act,1972 and under Rules, which have since been replaced by DCS Act,2003 and DCS Rules,2007.

In this regard, refer to your letter dated 24.04.2024, wherein Para 2 of your letter it's mentioned that under section 12(5) of the DCS Act,2003 r/w rule 12(9) of DCS Rules,2007 after on expiry of 90 days with deemed registration of Byelaws therein requesting for issuance of the registration certificate of our amended bylaws as per Sec.12(5) of the DCS Act,2003 under rule 12(9) of the DCS Rules,2007 without calling any further clarification as per provision under Rule 12(8), DCS Rules, 2007 that in case Registrar does not communication within ninety days the amendment in bye-laws shall be deemed to have been registered.

You are already aware that the communications in this regard was already made by this office on 11.12.2023, 30.01.2024, 22.02.2024, 18.03.2024 & 18.04.2024 with regard to certain clarifications were sought on the amended byelaws but no reply/clarification on the raised points was received from society till date. Moreover, the proposed amendments in byelaws of the society are not in consonance with the modal bye-laws of the society as per DSC Act,2003.

Therefore, the proposal of the society for Amendments of its Bye-Laws is hereby rejected. It is hereby directed to re-submit the amended by byelaws after removing the discrepancies thereon.

This issues with the prior approval of the Competent Authority.
