**ORDER**


Whereas, the Vindhyachal Cooperative Group Housing Society Ltd. Inder Enclave, P.O. Sunder Vihar, New Delhi-110087 is registered vide Registration No. 257/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, some major irregularities in society have been come into notice of this office viz. non-conduct of Statuary Audit since year 2012 till date, non-conduct of election of Managing Committee in society since year 2005, non-conduct of AGM since year 2006 & forcefully possession of society office and its resources by erstwhile Managing Committee.

And whereas Sh. G.S.Aggarwal, Retd. DANICS was appointed Administrator u/s 35(5) of DCS Act 2003 in Vindhyachal Cooperative Group Housing Society Ltd. vide this Office Order 13.06.2024. However, Sh. G.S.Aggarwal has submitted a letter on 28.06.2024 and refused to the appointment.

Now therefore, the undersigned hereby convey the approval of the Competent Authority to appoint Sh. V. K. Rastogi as Administrator u/s 35(5) of DCS Act 2003 in Vindhyachal Cooperative Group Housing Society Ltd, with immediate effect for 90 days to look after day to day affairs of the society, complete pending audit in society and thereafter conduct elections for the new Management Committee of the society. He will also submit a monthly status report of the society in this office.

Administrator will be paid Rs 10,000/- (Rs Ten Thousand Only) per month as honorarium plus conveyance charges from the society fund for this purpose.
