And whereas, the existing 06 Management Committee members have resigned out of 07 members, now the M.C. has become non-functional and the Ex-President has requested this office to conduct Election of new Management Committee.

And whereas, in exercise of the powers vested under Section 35(5) of DCS Act, 2003, the Competent Authority has approved that the affairs of the society shall be managed by an Administrator-cum-Returning Officer.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint **Sh. K.S.Meena, IAS(Retd.), as Administrator-Cum-Returning Officer** in Indian Airlines Co-operative GHS Ltd.(Regn. No.130-GH) under section 35 (5) of DCS Act, 2003 to look after the day-to-day affairs of the society and to conduct the election of the M.C. within 90 days from the issue of this order.

He will be paid Rs.10,000/- (Rupees Ten Thousand Only) per month along with conveyance charges as remuneration from the society funds for this purpose.
