Whereas, Delhi Nagrik Sehkari Bank Limited, Regd. Office: 720, Near Ghanta Ghar, Subzi Mandi, Delhi-110007 (*hereinafter referred to as 'Bank'*), is registered with this department under the provisions of Delhi Cooperative Societies Act, 2003 (*hereinafter referred to as 'Act'*) and rules framed thereunder.

The Chief Executive Officer of the Bank has informed vide letter dated 27/06/2024, that the last election of the society was held on 17/10/2021 and accordingly the term of the existing Managing Committee is expiring on 16/10/2024 and therefore, requested to appoint an Returning Officer to conduct the election for the Constitution of the new Managing Committee.

Now therefore, I, Surinder Narang, Assistant Registrar (Banking) O/o RCS, hereby convey the approval of the Competent Authority to appoint Shri Bajran Lal, DANICS (Retd.) as Returning Officer in Delhi Nagrik Sehkari Bank Limited, under section 35(1) of DCS Act, 2003 with remuneration of Rs. 10,000/- (Rupees Ten Thousand Only/-) consolidated from the society's fund plus travelling allowance from the society's fund. The Returning Officer may hold election within a period of 90 days.

The other expenses of the election will be met out from the fund of the society. The election of Managing Committee of the aforesaid society shall be conducted as per the provisions of the DCS Act, 2003 and rules framed thereunder.
