ORDER

Whereas, the Lion's Cooperative Group Housing Society Ltd, Outer Ring Road, J Block, Vikas Puri, Delhi-18 is registered vide Registration No. 305/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

Whereas, Sh. Manmohan Chopra, President as well as 5 members of the Managing Committee namely, Sh. Kishore Chand Devgan, Sh. Gurinder Sethi, Capt. Suhas Sandilya, Sh. Arvind Sood & Mrs. Sneh Chandna, resigned from the Managing Committee of the Society, moreover one member name of Smt. Rita Kumari Nanda has expired, resultantly the Present Managing Committee reduced to only ~~Four~~(04) members out of which one member is out of India and thus unable to run the affairs of the society as per the provisions contained in DCS Act 2003 and Rules, 2007 a& registered Bye-laws of the society.

Whereas, in view of provisions contained in Sec 35(5) of DCS Act, 2003 an Administrator is required to be appointed to look after the day to day affairs of the society and to conduct fresh election in the society.

Now, therefore, the undersigned hereby convey the approval of the Competent Authority to appoint Sh. A.K. Sharma, Retd. Sr.Director/Scientist 'G', Govt. of India as Administrator u/s 35(5) of DCS Act 2003 in Lion's Cooperative Group Housing Society Ltd, with immediate effect for 90 days to look after the day to day affairs of the society and to conduct elections of the new Managing Committee of the society. He will also submit a regular monthly status report of the society to this office.

He will be paid Rs 10,000/- (Rs Ten Thousand Only) per month as honorarium plus conveyance charges from the society fund for this purpose.

This issues with the prior approval of the Competent Authority.


