Whereas, Ministry of Home Affairs Government Employees Hire Purchase Cooperative Society Limited, Hall no -6 Jalebi Chowk, North Block, New Delhi-110001 (*hereinafter referred to as 'Society'*), is registered with this department under the provisions of Delhi Cooperative Societies Act, 2003 (*hereinafter referred to as 'Act'*) and rules framed thereunder.

Vide letter dated 20/05/2024, Sh. Vinod Kumar Nagpal, Member of Managing Committee, Membership no-295, informed that the last election of the society was held on 2019.

Whereas, as per the record available in O/o RCS Audit Branch the date of last election held was on 09/03/2019.

Whereas, the term of Managing Committee has already expired on 09/03/2022.

Now therefore, I, Surinder Narang, Assistant Registrar (Banking) O/o RCS, hereby convey the approval of the Competent Authority to appoint Shri A.C Chaudhary, Assistant Accounts Officer as Administrator-cum Returning Officer of the Society, in term of section 35(5) of DCS Act, 2003. A sum of **Rs. 10,000/- (Rupees Ten Thousand Only/-)** per month as remuneration plus conveyance allowance will be paid to him from the society's fund. The Returning Officer may hold election within a period of 90 days.

The expenses for conducting the election shall be met out from the fund of the Society. The election of MC of the Society shall be conducted as per the provisions of the Act read with rules and bye-laws framed thereunder.
