OBSERVATIONS AND FINDINGS OF THE COMMITTEE

At the outset, the committee was apprised regarding order dated 24.04.2024 passed by the Hon'ble High Court in W.P (C) No. 5666/2024, titled as Ravi Shankar CHGS Ltd. V/s RCS & Anr. On perusal of the same, the Committee is of the view that the facts as were presented by the petitioner (which is recorded in para-4 of the order dated 24.04.2024) are not correct description of the factual scenario and therefore, steps be taken in consultation with panel counsel to apprise the Hon'ble High Court with the true nature of facts.

The Committee examine the agenda regarding clearance of membership of Ms. Visakha Chawala & Sh. Jitender Kumar Bansal both members of the Ravi Shankar CGHS Ltd., Dwarka, New Delhi and other 140 members of the society. Detailed discussions were held regarding their eligibility and membership.

- i. As regards the membership of Ms. Visakha Chawala, the committee observed that she was barely 20 years of age when she was enrolled in the year 1996, though the society had already been registered in the year 1983. Details be provided regarding her application and enrolment as member of the society as proceedings register of the society was missing at the time of her registration as member of the society. The RCS may re-examine whether due procedure was followed in her admission as member of the society in terms of DCS Act & DCS Rules applicable.
- ii. The Committee directed that cases of all other members shall also be re-examined on the lines of discussion of Ms. Visakha Chawala. Their details at the time of enrollment, resignation, expulsion and cessation as a member of the society should be properly examined to ensure that no violation of the provisions of DCS Act & DCS Rules and relevant rules thereof has been committed.
- iii. The committee observed that members have been enrolled in the society during the period i.e. 1993-98 when Proceeding Register of the society was lost and FIR was lodged on this account. It required the details of police investigation and outcome of the decision of court, if any. Committee also enquired if any other documents were lost besides abovementioned proceeding register. The committee






directed that documents of the members enrolled during aforesaid period may be carefully examined.

- iv. The Committee observed that as per Agenda Notice, in 31 cases of resignation/cessation, payments were made in cash which is not permissible in view of departmental directive NoF.47/96/Policy/R.C.S/99-2000/1957-1958 dated 30.05.2000 and also in violation of the extant provisions.
- v. The Committee directed to re-examine the cases where memberships were transferred from the original member to his/her nominee or legal representative. RCS office should ensure that no procedural violation has been made in such cases.
- vi. As per agenda note, some verification certificates (Form- F) were not found with date thereon. The committee directed to require the verification certificates afresh in such cases with date and signature of the applicant and attesting officer.
- vii. As per agenda note, some of share certificates were found issued on dates much after date of enrollment. Clarification is required by the Committee in such cases.

The Rule-90 Committee directed that in all other cases too which have been forwarded by the Branch-in-Charges to the Policy Branch of the Department for placing the same for consideration of the 'Rule-90 Committee' should be re-examined on similar lines, before placing the same to this Committee.
