DISSOLUTION CERTIFICATE

It is to certify that in pursuance to Delhi Co-operative Societies Act, 2003, a society by the name and style of "PNB Officers' Cooperative Thrift and Credit Society Ltd., Delhi at QP-95, Maurya Enclave, Pitampura, Delhi- 110034 in the National Capital Territory of Delhi, was registered in the office of the Registrar Cooperative Societies.
