**ORDER**

Whereas JAI LAKSHMI CGHS LTD., PLOT NO. 59, I.P. EXTENSION. PATPARGANJ, DELHI-110092 is registered vide Registration No. 270-GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, The present M.C of society has failed to conduct election of the new committee before the expiry of its term and comply with the DCS Act, 2003 and Rules, 2007 (as per Schedule-II) and the violation/shortcomings are as under:-

- (i) The M.C of society failed to meet at least sixty clear days in advance of the date of expiration of its present term and by resolution determine the date, time and place for convening a general body meeting for conduct of election of its successor Committee.
- (ii) The society failed to conduct the election before the expiry of its present term upto i.e. 31.07.2024.
- (iii) The M.C of society failed to prepare a list of members as it stood on thirty days before the date fixed for the inviting nomination, and publish copies of the said list by affixing them upon the Notice Board.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint Sh. M.K. Gupta, Retd. Bank Manager as Administrator-cum-RO in Jai Lakshmi CGHS Ltd., Plot No. 59, I.P. Extension, Patparganj, Delhi-110092 under section 35 (5) of DCS Act, 2003 to look after the day-to-day affairs of the society and to conduct the election of the M.C. within 90 days from the issue of this order.

He will be paid Rs.10,000/- (Rupees Ten Thousand Only) per month as remuneration along with conveyance from the society funds for this purpose.
