ORDER U/s 35(5) OF DCS ACT, 2003

Whereas, East End Apartment Co-operative Group Housing Society Ltd. is registered vide, registration No.524A-GH with this department under the provisions of DCS Act & Rules and Bye-laws of the society.

And whereas, Sh. Jitendra Sihwag, Deputy Secretary to the Govt. of India, Ministry of Corporate Affairs, who was appointed as Administrator-cum-Returning Officer in East End Apartment CGHS Ltd. vide this office order dated 16/07/2024 has resigned vide email dated 20.09.2024.
