ORDER

Whereas The Vaish Cooperative Adarsh Bank Limited, 03, Netaji Subhash Marg, Darya Ganj, New Delhi- 110002, is registered with this department under the provisions of Delhi Cooperative Societies Act, 2003 and Rules 2007.

Whereas, under section 35(1) of DCS Act, 2003 as per the Provision of Section 35(1) of DCS Act, 2003 the entire process of the election of the Managing Committee of the Cooperative Societies shall be conducted by Returning Officer to be appointed by the Government, who shall not be below the rank of Gazetted Officer.

Whereas, the last election of the Managing Committee of Bank was held on 05<sup>th</sup> September, 2021. The terms of office of the elected members of the committee shall be three years as per provisions of Section 35(3) of the DCS Act 2003.

Whereas, Sh. Harshit Jain, Deputy Secretary (Home-IIA), vide his letter dated 13.08.2024 requested to cancel his appointment as RO on account of Heart Angioplasty, who had been appointed as RO of the said bank vide this office order dated 09.08.2024.

Whereas, Sh. Shri Amit Kumar Pamasi, (Dy. Dir.) who was subsequently appointed as Returning Officer in The Vaish Cooperative Adarsh Bank Limited, under section 35(1) of DCS Act, 2003, vide order 03.09.2024 has been transferred to Dadra and Nagar Haveli & Daman and Diu vide MHA's order dated 12.09.2024.

Now therefore, I, Surinder Narang, Assistant Registrar (Banking) O/o RCS, hereby convey the approval of the Competent Authority to appoint Sh. R.S. Krishnan, (Dy. Secy.) as Administrator-cum-RO in The Vaish Cooperative Adarsh Bank Limited, under section 35(5) of DCS Act, 2003 with remuneration of Rs. 10,000/- (Rupees Ten Thousand Only/-) per month plus travelling allowance from the society's fund. The Administrator-cum-R.O. may hold election within a period of 90 days.
