ORDER

Whereas, the Kangra Adarsh Cooperative Group Housing Society Ltd, K-377A, Kangra Niketan, Vikas Puri, Delhi-18 is registered vide Registration No. 33/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

Whereas, Sh. Harvinder Kumar, Dy. Director, Income Tax was appointed as Administrator u/s 35(5) to conduct the elections of the Management Committee of the society within 90 days on dated 23.09.2024.

Whereas, the 110 members of the society vide its letter dated 04.10.2024 alleging the misleading behaviour of Sh. Harvinder Kumar, Administrator cum-R.O. and also alleging the fear about the conduct of free and fair election in the society, hence requested for the change of present Administrator.

Now, therefore, the undersigned hereby convey the approval of the Competent Authority to appoint Sh. *Subhash Gupta, Retd Adhoc DANICS in place of Sh. Harvinder Kumar, Dy. Director, Income Tax* as Administrator-cum-R.O. u/s 35(5) of DCS Act 2003 in Kangra Adarsh CGHS Ltd., with immediate effect for 90 days to look after the day to day affairs of the society and to conduct elections of the new Managing Committee of the society. He will also submit a monthly status report of the society in this office.

He will be paid Rs 10,000/- (Rs Ten Thousand Only) per month as honorarium plus conveyance charges from the society fund for this purpose.
